UP Chess Sports Association & Ballia District Chess Association is organizing UP State Chess Championship Under 15 (Girls) 2024-25 from 10-07-2024 to 12-07-2024. Free lodging (dormitory) will be provided to all the selected entries and one official manager of respective district team. Others and accompanying persons will be charged Rs.500/- per person.

Prizes: Cash prizes will be awarded in following manner: -

1st - 3000/-, 2nd - 2000/-, 3rd - 1200/-, 4th - 650/-, 5th - 650/-.

Entry Fee: - For regular entry Rs.600/- and for special entry Rs.1000/-.

Entries/Entry Fee: All entries including special entries should come through the concerned District Association. However, the Entry form should be sent together with attested copy of original date of birth certificate (Birth Certificates from Panchayat / Municipality /Corporation only accepted)

Registration: - All participants must be registered with AICF & UPCSA for the year 2024-2025. registration fees of AICF is Rs.300/- Online AICF registration can be done at the website <u>www.aicf.in/players</u>, registration fees of UPCSA & belonging District is Rs. 225/-, deposit the fee in UPCSA bank account (bank details are given below) and fill the google form, link given below:

Last Date of Entry: - Please note that the entry fee structure is valid till 6th July 2024. Thereafter a late fee of Rs.200/- per player will be levied. No entry will be entertained after 8th July 2024 (up to 17:00 hrs)

Food: - Since there is no marketplace nearby the venue, hence Veg food (Breakfast, Lunch and Dinner) will be provided by the organizer on prepayment basis (Rs 900/- per person from 09/07/24 Dinner to 12/07/24 Lunch). Interested players and accompanying person may book in advance.

Age Limit: - Players should be born on or after 01.01.2009.

Age Proof: - Each participant must produce a valid birth certificate to prove his /her age. Certificates from School will not be accepted. Certificates should preferably be from the Panchayat, Municipality or Corporation obtained soon after birth. Players without date of birth certificates will not be allowed to participate.

The date of birth certificates registered within one year of the birth of the player alone will be recognized and allowed to participate. No district association shall recommend any player who doesn't come under the above criteria.

Tournament System: -

i. The tournament will be played under the Swiss System of league governed by latest FIDE rules for chess.

ii. Each session will be of 60 minutes + 30 seconds increment from the first move.

iii. FIDE Tie break Rule will be applicable.

iv. Protest if any, can be made within 15 minutes from the completion of the games along with a protest fee of Rs.2000/ which is refundable if protest is upheld.

v. The decision of Appeals committee will be final and binding to all.

ELIGIBILITY: -

i. Four Players from every affiliated District/Unit of UPCSA (recommended by district secretary on district letter head). All the arrears of affiliation fee including current year (2024-25) and other dues (if any) must be cleared by the concerned District/Unit prior to submission of entries. District/Units will not be allowed if arrears are not cleared. Players participating from district without association have to pay Rs. 1000/- entry fees for the tournament.

ii. Top two players from the previous U.P State U-7, U-9, U-11 & U-13 Girls Chess Championship and four players from the previous U.P State Girls U-15, U-19 & Women Chess Championship as regular entry subject to age stipulation.

iii. Two players who could not participated in their District tournament, as may be nominated by the Hon. Gen. Secretary of UPCSA following the recommendation of concerned District Secretary as regular entry.

iv. Once entry fee is paid will not be refunded.
